CRYPTOCURRENCIES & BLOCKCHAIN: THE FASTEST-GROWING INVESTING ASSET – *EVER!*

There are now millions of cryptocurrencies. And while some of these are legitimate and worth owning, others are not so legitimate. It's imperative that you do your own research before investing.

What I have realised over the last 25 years is that besides doing my research, I have to use a proven strategy that works over time, in any market direction. No matter if we are in a bull or bear market.

That is the reason I took my successful strategy (created over the last 25 years), and adapted it to cryptos – and discovered it works even better with cryptos because of crypto's volatility! I show you exactly why and how this strategy works below.

But first, it's important I tell you about Trump's 5 Reserve Coins because these include some of the most popular, well-known and longstanding cryptos out there. It means Trump is giving these cryptos special status, which in turn means they are going to be key digital currencies in the future and the world becomes ever-more dependent on crypto and AI.

These 5 are also the coins I hold. I explain why I am holding them – and then reveal two bonus coins that most investors are overlooking!

TRUMP'S 5 RESERVE COINS

1 Bitcoin (BTC)

What problem does it solve?

Bitcoin is known as the digital gold standard in the cryptocurrency network. It's the first ever cryptocurrency invented and is the pioneer of blockchain technology that made digital money possible, solving the problem of duplication and manipulation.

Thanks to its blockchain technology, you have ultimate control over your money and transactions without having to go through a third party such as the bank or PayPal, making transactions much faster and cheaper.

One major advantage that it has over other cryptocurrencies is Bitcoin is impossible to counterfeit or inflate. There will be only 21 million Bitcoin created for mining, no more no less. By around 2140, all Bitcoin will already be mined.

Over the years Bitcoin's value has fluctuated tremendously from zero to over \$100,000 per Bitcoin! Its market cap is currently more than double the next highest crypto, Ethereum.

Do I hold Bitcoin?

Bitcoin is my largest holding.

2 Ethereum (ETH)

The second most popular currency in terms of market cap is Ethereum. Like Bitcoin, Ethereum is a part of a blockchain network. The main difference between the two currencies is that the Bitcoin blockchain focuses on tracking ownership of the digital currency, while the Ethereum blockchain focuses on running the programming code or network.

What problem does it solve?

Ethereum solves the problems of legal contracts online, eliminating middlemen taking fees from transactions.

Firstly, a third party cannot make any changes to the data. The system is also tamper and corruption-proof. This is because Ethereum is built based on a network formed around a consensus which, as a result, makes censorship impossible.

Secondly, just like Bitcoin, Ethereum is backed up by secure cryptography. Therefore, the applications are well protected against any form of hacking. Ethereum has fluctuated in price over the years, before hitting an all-time high of \$4,891.

Do I hold Ethereum?

This is my second largest holding. I bought into Ethereum on 10 separate occasions as the price was falling from its high so I have a nice low average price. However, it will not be long before I start exiting my positions to get into newer, modern and more efficient technology and in 2025 sold 1/3rd of my position to do just that.

3 Ripple (XRP)

Ripple was launched in 2012 and is the leading provider of crypto solutions for businesses.

What problem does it solve?

Banks can use Ripple to make payments faster and cheaper, nationally and internationally. Ripple operates on an open-source and peer-to-peer decentralised platform that allows a transfer of money in any form, both fiat and cryptocurrency.

Ripple uses a middleman in currency transactions. The medium (the middleman) known as “Gateway” acts as a link in the network between two parties wanting to make a transaction. XRP’s all-time high price is \$3.40 per coin.

Do I hold Ripple?

I have three positions in Ripple due to a Tim Ferris podcast with Nick Szabo, the creator of Bit Gold. Nick said that the currencies that could cross the bridge between the current banking system and the new digital system would be the winners. Ripple is the first to attempt this. It now seems XRP is becoming the backbone of the new financial system. We will see!

4 Solana (SOL)

What problem does it solve?

Solana solves the problem of scalability and high transaction costs in blockchain networks. Traditional blockchains like Bitcoin and Ethereum often face network congestion and expensive gas fees, limiting accessibility for users worldwide. Solana’s unique architecture allows it to process thousands of transactions per second at a fraction of the cost, making it one of the fastest and most efficient blockchains available.

The core innovation behind Solana is its Proof-of-History (PoH) consensus mechanism, which enables faster transaction validation while maintaining security and decentralisation. By integrating PoH with Proof-of-Stake (PoS), Solana ensures high throughput without compromising security.

Solana also supports smart contracts and decentralised applications (dApps), making it a strong competitor in the DeFi, NFT, and Web3 gaming sectors. Its low fees and high-speed transactions empower developers to build scalable solutions that can reach global audiences without friction.

Unlike privacy-focused cryptocurrencies like Monero, Solana prioritises speed, efficiency, and scalability, making it ideal for mainstream adoption, institutional use, and Web3 innovation.

Solana reached an all-time high price of \$294.

Do I own Solana?

Yes, I rotated a portion of my ETH into SOL and Solana is now one of my biggest holdings.

5 Cardano (ADA)

What problem does it solve?

Cardano is a next-gen blockchain designed for scalability, sustainability, and efficiency. Using the Ouroboros proof-of-stake protocol, it processes transactions securely with low energy costs. Its dual-layer structure – Settlement Layer (CSL) for transactions and Computing Layer (CCL) for smart contracts – enhances speed and scalability.

Launched in 2017 by Ethereum co-founder Charles Hoskinson, Cardano is a third-generation blockchain built on academic research. Its Ouroboros consensus mechanism was developed by cryptographers from leading universities to maximise security and efficiency.

Unlike Ethereum-based tokens, Cardano's native assets operate on the same architecture as ADA, reducing fees and increasing security. The platform emphasises peer-reviewed research to ensure long-term stability.

Use case

Cardano enables decentralised identity management, offering tamper-proof, verifiable credentials for finance, governance, and other industries.

Cardano's all-time high price is \$3.10.

Do I hold Cardano?

I do own Cardano but am not adding any more as there isn't much happening and they don't have many users. In fact, I am surprised that Trump mentioned it at all.

YOUR BONUS COINS

1 Fetch.ai (FET)

Fetch.ai is part of the Artificial Superintelligence Alliance (ASI Alliance) which is a collaborative initiative among leading AI and blockchain platforms, including SingularityNET, and Ocean Protocol.

What problem does it solve?

The ASI Alliance was established to advance artificial intelligence (AI) by leveraging blockchain technology. The alliance aims to create a decentralised ecosystem where AI services can operate securely and transparently.

Each member brings unique strengths to the alliance:

- **Fetch.ai (FET):** Specialises in autonomous AI agents that perform tasks such as data retrieval and complex decision-making.
- **SingularityNET (AGIX):** Offers a decentralised marketplace for AI services, allowing developers to monetise their AI tools and algorithms.
- **Ocean Protocol (OCEAN):** Provides a platform for data sharing and monetisation, ensuring data providers retain control over their information.

By integrating these capabilities, the ASI Alliance seeks to foster innovation in AI development, promote data sharing, and ensure that AI technologies are accessible and beneficial to a broader audience.

It helps businesses and industries like finance, transportation, and energy run more efficiently by using AI-powered digital assistants, known as “digital twins.” These digital twins can make decisions, complete tasks, and interact with each other without needing constant human input. Fetch.ai is powered by its cryptocurrency token FET, which is used to create and train these digital assistants.

FET has reached an all-time high price of \$3.47.

Do I hold FET?

I bought FET several times to get a nice average price before it became part of the Artificial Superintelligence Alliance. I am up a lot on this and will continue to hold because AI is the main trend in the market.

2 Sui (SUI)

What problem does it solve?

Sui is a fast and scalable Layer 1 blockchain designed for handling digital assets like cryptocurrencies, NFTs, and financial services. It allows transactions to happen quickly and at a low cost. Instead of processing transactions one by one, Sui can handle many at the same time, making it much more efficient than older blockchains.

Sui was created by Mysten Labs, a team of former Meta (Facebook) engineers, to improve blockchain speed and scalability. In 2022, it introduced a system called Bullshark to reduce delays and allow more users to participate, even with lower-powered computers.

Key Features:

- **Fast Transactions:** Handles multiple transactions at once, avoiding slowdowns.
- **Low Costs:** Stores assets efficiently, reducing fees.
- **Better for Gaming & NFTs:** Makes retrieving data cheaper and updating assets easier.

Sui's unique design helps it support high-speed applications like gaming, finance, and digital asset management. Sui features horizontal scaling, allowing transactions to be processed in parallel, avoiding network congestion. The network also supports sparse replay, lowering data retrieval expenses for applications like gaming. Unlike traditional blockchains, Sui does not rely on Merkle tree indexing, making asset updates more efficient.

Use case

Sui supports high-speed applications such as gaming, decentralised finance (DeFi), and NFT marketplaces. Its ability to handle large-scale transactions and low-cost on-chain storage makes it a promising platform for digital asset management and user-friendly blockchain applications.

Sui reached its all-time high price of \$5.35.

Do I hold SUI?

I was a bit late to the party with SUI but now that it is dubbed “the Solana Killer” I have been using all pullbacks to lower my average position.

HOW TO FIND THE HIGH & THE STEPS TO BUY

1 Open a chart using daily candles and locate all the lows the Cryptocurrency has been over the last year, as identified by the blue arrows in the picture below.

2 Once we find the lows we have to measure if the Cryptocurrency from the low has recovered 80% or more. When we measure from the low to high we always measure left to right (As seen in the picture below – there is a recovery of over 139%).



If the recovery is not 80% we look at the next low (on the left) and measure for an 80% recovery. We do this until we see that the Cryptocurrency has recovered 80% from the low.

Once we have found an 80% recovery then we have found our current high.

3 Once we have located our current high, we can start placing orders in relation to the CCA strategy.

When we are buying, we are looking to enter the market at drops of 20%, 30%, 40%, etc. from the recent high. We have a CCA calculator available for members of Your Crypto Club which does all these calculations for you.

Keep in mind that each time we enter, we invest 25% more than the last time. Since we invest 25% more each time we get in, our average price comes down a lot.

Example:



HOW TO TAKE PROFIT ONCE YOU ARE IN THE TRADE

- 1 We never sell everything since we do not want to be on the side-lines when the new bull market occurs. BUT we want to take some profits along the way in case the price drops so we can reinvest. The picture below shows the average price of your position.



- 2 Once you are in the position we then sell 20% of our holdings every time we are 50% in profit from our average position. See the picture below.

WHAT IS CRYPTOCURRENCY?

Cryptocurrency is a digital or virtual currency secured by cryptography, making it nearly impossible to counterfeit. Unlike traditional currencies, most cryptos operate on decentralised blockchain networks.

IS CRYPTO INVESTING SAFE?

Crypto is classified as a high-risk investment due to price volatility, hacking risks of centralised exchanges, and regulatory uncertainties. However, using secure wallets, enabling two-factor authentication, and diversifying investments can help manage risk.

HOW DO I BUY AND SELL CRYPTO?

You can buy and sell crypto through:

Centralised Exchanges (CEXs) – Binance, Coinbase, Kraken.

Decentralised Exchanges (DEXs) – Uniswap, PancakeSwap, SushiSwap.

Peer-to-Peer (P2P) platforms – Where you buy directly from other individuals.

HOW MUCH MONEY CAN I MAKE WITH CRYPTO INVESTING?

This depends on your initial investment amount. However, during our thorough and extensive education we show you real strategies that together can help you achieve 15% to 72% a year if followed correctly, depending on market conditions.

HOW DO I STORE MY CRYPTO SAFELY?

- Hot Wallets (online) – Convenient but vulnerable to hacks.
- Cold Wallets (offline, like Ledger or Trezor) – Highly secure, best for long-term storage.
- Multi-Signature Wallets – Require multiple approvals to access funds, increasing security.

CAN I MAKE PASSIVE INCOME WITH CRYPTO?

Yes! You can earn passive income through:

- Staking – Locking up crypto to support the network and earn rewards.
- Yield Farming – Providing liquidity on DeFi platforms for interest.
- Lending – Loaning crypto for interest on platforms like Aave or Compound.
